Sub : APSCSCL – PDS – LEVY SUGAR – District-wise Review of lifting of levy sugar for the Month of August 2005 – Incorporation of priority in the Movement Orders being issued by the Dist.Managers – Reg.

On review of lifting of levy sugar for the month of August 2005, it is observed that most of the District Managers are giving Movement Order to their sugar transport contractor for the entire quantity allotted to their respective districts at a stretch, without any priority break-up. This will give scope to the contractor to move the stocks to the allotted MLS points as per his convenience and choice, without taking into account actual requirement.

In order to prevent such movement at the whim and fancy of the contractor / agent / driver , all the District Managers are hereby directed to issue Movement Orders bifurcating the district allotment into two or three cycles as per priority. In the first cycle all MLS Points should be covered by one load (10 /20 MTs) of arrivals as 1st priority so that sugar stocks are available at all MLS Points at the beginning of the month itself. The MLS points where requirement is more etc., are to be listed in the 2nd priority to ensure that at least second load of stocks are positioned in those points in the second cycle.

It must be monitored closely by the Dist.Managers and ensure that stocks are moved by the transport contractor strictly in accordance with the priority movement order without any deviation to cater to the requirement of all MLS points as per the requirement and local circumstances.

In view of the above, a format of Movement Order is given below.

All the Dist.Managers are requested to issue movement orders to their contractors in the above format from September-2005 onwards. If they have already issued movement orders to the contractors for September-2005, the same may be revised and a copy sent to Head Office for reference and record.

NOTE:-

- I. 1ST PRIORITY --- 1ST cycle of supplying one lorry load (10/20 MTs) to all MLS Points.

2nd PRIORITY--- 2nd cycle of movement --- give priority to MLS Points where requirement is high

3rd PRIORITY --- 3rd cycle of movement --- balance requirement of MLS Points to be covered.

- II. In each priority, cycle of movement should be followed ie., for example, if 40 MTs is required in 2nd priority to a MLS Point then 2 Lorry Loads (20 MTsx 2) should be moved simultaneously to the MLS Points. The next Lorry Load (LL) can then go to new point in the priority.

- III. Only after completing all cycles of movement to a MLS Point in 1st priority, the movement to 2nd priority shall be taken up.

- IV. A cycle means number of lorry loads requirement to meet the total requirement of a MLS Point in each priority in multiples of 10 / 15 / 20 MTs as per lorry capacity.
