The Food Corporation of India has been requested for making movement of 66 rakes for A.P. rice and has planned 24 out of 135 rakes for Ex.north rice movement for meeting the requirement under PDS, Welfare Schemes and SGRY in December, 2005.

The next round of planning for January, 2006 onwards and balance 111 ex.North rice rakes will also be going on as per levy arrivals.

All the District Managers are therefore requested to coordinate with the DM, FCI concerned to plan the DESTINATION POINTS for the rakes.

This is important not only from economic movement point of view, but also to ensure that the rice stocks are available simultaneously at more than one FCI godown in the district so that lifting and release of rice for PDS and other schemes can go on at a brisk pace.

The DMs may request the Joint Collectors to discuss the issue with the FCI officials locally and ensure that the DESTINATION PLANNING is done in

oordination to fulfill the objective of economic movement as well as the timely supply of rice.

To assess the available godown space, the local Manager of CWC and APSWC may also be involved in the discussion for DESTINATION PLANNING.

The destination plan for the rakes already moved/ on run as well as the rakes to be moved during this month may be got sent by the DM, FCI to their Regional Office so that the same may be incorporated in the rake plan sent to New Delhi from RO, FCI, Hyderabad.

It may also be noted that this exercise should become a regular feature of the planning for priority movement of rice in the district during the coming period, as per various instructions already issued in previous circulars, since lot of rake movement will be taking place once the levy procurement of rice increases substantially all over the State. Hence, it is necessary to undertake advance planning in coordination with FCI at the initial stage itself.

Based on the monthly requirement for PDS, Welfare Schemes and likely off-take of SGRY, the destination-wise rice to be moved and stored by FCI needs to be planned and informed to them so as to enable them to incorporate it in their Rake Movement Planning.

Finally, it may be noted that by the above coordination and planning any savings affected in Government expenditure by avoiding unnecessary uneconomic movement would be a saving of the public exchequer. Therefore, from the Government point of view, it is one and the same whether the FCI or the CSC affects economy in expenditure by way of preparing COORDINATED MOVEMENT and DESTINATION PLAN in the overall interest of Government funds.
