The Government of India through reference cited have communicated the issue prices of Levy Sugar by the factories for the sugar produced in 2005-2006. These prices will come into force with effect from 17.11.2005 i.e., the date of issue of Official Gazette notification. There is no change in the price of 2005-06 season's production.

The levy prices of ISS Grades of Sugar including Excise Duty and Education Cess for the stocks to be transported by road as fixed by the Govt. of India are as follows.

They are also requested to send sugar PEF statements to Head Office Accounts Section as per the said rates clearly bifurcating quantity lifted up to 16.11.2005 and quantity lifted from 17.11.2005 from the factories to prefer claims with the Food Corporation of India.

The sugar purchase vouchers shall be entered on priority in NIC software so that claims can be easily generated from the software.

Government of India have communicated the ex-factory prices of levy sugar for the season's production of 2005-2006 vide reference cited. A copy of the same has been communicated by Commissioner of Civil Supplies & Consumer Affairs and put up below for kind perusal.

The levy prices of ISS Grades of Sugar including Excise Duty and Education Cess for the stocks to be transported by road as fixed by the Govt. of India are as follows.
