The Sugar Movement Plan for March - 2006 is enclosed.

In the reference 1st cited Government of India have allotted a quantity of **9725.2 Mts** of Levy Sugar on A.P Sugar Factories. Out of this 9,691.9 Mts pertaining to 2005-2006 Season's production and the balance Qty. of 33.3 Mts from 2004-05 season's production. In the reference 2nd cited, GOI have accorded permission to Chamudeshwari(28101) and Siddapur(50301) to release 1725.0 MTs and 700.0 MTs. respectively from 2005-06 season's production against December 2005 allotment with the validity period to lift the stocks upto 7-4-2006. On confirmation of availability of stocks with the above (2) Karnataka sugar mills, the same be re-allotted to the nearby district or clubbed to April 2006 allotment as the case may be.

In the Ref.3rd cited, GOI have cancelled the allotment of 2094.5 MTs earlier allotted on Chodavaram for Feb.2006 allotment, and reallocated the same on Chelluru (25901) factory from 2005-06 season's production. The factory authorities have confirmed availability of sugar stocks and ready to deliver stocks on payment of cost.

The District Managers are requested to keep the available stocks over and above CCS allotment as buffer and under any circumstances **the releases should not exceed CCS allotment.**

The validity period to lift the stocks for March-06 allotment is upto 19-04.2006. The District Managers are directed to complete their lifting by 15.03.2006.

All the District Managers are requested to lift the stocks quickly and position them in the MLS points judiciously. The lifting of March-2006 allotment has to be completed by **15-3-2006.**

The Dist.Managers of Srikakulam, Vizianagaram, Visakhapatnam and East Godavari may move the stocks departmentally as per the transport rates approved by their respective District Tender Committees for February-2006 allotment also till adhoc contractor is appointed.

All the District Managers are requested to contact the concerned Sugar factory authorities about availability of levy sugar stocks before making payment. If any factory is not delivering sugar on any ground, the matter may be taken up with that sugar factory through the concerned Collector/Joint Collector under copy marked to Head Office.

The District Managers should not release more than the allotment made by the Commissioner of Civil Supplies and Consumer Affairs, Andhra Pradesh,

Hyderabad taking into account the opening balance available with the MLS points and keep the remaining stocks as buffer in the district. The said buffer will be taken into account for next month allotment. Any excess utilization this month would lead to proportionate deficit in next month. Hence, all District Managers must stick to CCS allotment compulsorily for utilizing PDS sugar in March-2006.

All the Dist.Managers and Zonal Managers are requested to immediately work out the arrangements for monitoring the movement of sugar under Stage-I transportation from sugar factories to destination MLS points, consignment-wise on daily basis with immediate effect. They are requested to follow the instructions already issued in Circular No. PDS-5 dt 2-7-2005.

They should send lifting SMS as per circular No.A&V 20 and 24 also from the concerned District Manager's office.

The above instructions shall be followed scrupulously with immediate effect.
