In the references cited it was informed that the APSCSCL has extended the Employee Provident Fund(EPF) benefits in accordance with the EPF & MP Act 1952, to all eligible hamalties working at MLS points of the Corporation with effect from 01.04.2006. The EPF recoveries and remittances were commenced from February 2008 onwards. The arrears pertaining to the period from 01.04.2006 to 31.01.2008(including Employer contribution) were remitted as detailed hereunder :

- 1) From 01.04.2006 to 31.03.2007 paid in July 2009,(12 months)
- 2) From 01.04.2007 to 30.09.2007 paid in May 2009, (6 months)
- 3) From 01.10.2007 to 31.01.2008 paid in January 2009,(4 months)

The arrears were credited to the individual accounts in lumpsum in the months of January 2009, May 2009 and July 2009 as detailed above. A copy of the Annual pay slip issued to the hamalties for the year 2008-09 and 2009-10 is enclosed herewith to show it as illustration.

In the recent meeting held on dt.10.06.2013 the hamalties have represented that the details of crediting the arrears are not informed to them.

Therefore the District Managers are requested to inform the above facts to the hamalties duly conducting a meeting of their leaders at District level. This information shall be communicated to all MLSP incharges to inform the hamalties working at MLSP.

The action taken in this regard shall be informed to the office.
