The attention of the District Managers is invited to the subject and reference cited.

In the circular issued vide reference cited, instructions were issued to all District Managers and Zonal Managers to furnish the information with regard to the Aadhaar Number, Bank Account Number, name of the Bank, Bank IFSC code to furnish to Regional Provident Fund Commissioner for implementation of Direct Cash Transfer under various Schemes announced by the Government of India. However, the District Managers and Zonal Managers have not furnished the information till date.

In the reference 2nd cited office of the EPF Organisation has informed that they are in the process of allotting Universal Account Number(UAN) to each of the employee contributing to Employees Provident Fund in accordance with the Government of India guidelines. The EPF Commissioner requested for furnishing of information on AADHAR Number/NPR Number, PAN and Saving Bank Account Number, Name of Bank, IFSC code pertaining to all members to enable them to allot UAN.

All the District Managers and Zonal Managers, therefore once again requested to furnish the information pertaining to all members i.e. Regular employees and Hamalies working in their districts within a week from the date of receipt of this circular in the proforma prescribed below along with the Xerox copies of Aadhaar card, Pan card and Bank pass book(first page).


