The attention of the District Managers is invited to the circular 1st cited, wherein instructions have been issued to utilize the software developed and hosted in NIC website for the purpose of procurement of paddy under MSP and Levy Rice under DCP operations. Asst Manager(Accts) and accountants of all districts have been given hands on training to use the Software. Detailed Guidelines were already issued vide ref 2<sup>nd</sup> cited and the same is available in the website. Further the required login IDs and Passwords for all IKP/PPCs and Godowns were already communicated.

In this connection District Managers were also advised to impart necessary training to IKP / PPC staff and Godown staff to acquaintance them in usage of the Software, as the software is designed to take care of the procurement of paddy at PPC/ IKP centres, movement of paddy from IKP centres to Rice Mills and delivery of CMR rice to FCI besides procurement of levy rice under DCP. The billing Software along with the reports pertaining to Mill wise and Godown wise procurement is also available for procurement of levy rice under DCP operations. The Software provides for required reports like IKP wise and Mill wise Subsidiary registers to monitor the paddy procurement, issue to rice mills and delivery of CMR Rice to FCI by rice millers. Thus by utilizing the software and posting the entries from the level of paddy procurement to delivery of CMR Rice, DMs will be having real time data to have better control to persuade the Millers to deliver CMR Rice.

In view of fast approaching of paddy production and procurement season (KMS 2013-14) there is every need to give necessary training once again to the IKP/PPC and godown assistants etc in usage of the software and to post the data on day to day basis. Hence District Managers are once again advised to take up training of the concerned immediately and prepare them for utilizing the software. The receipt of the circular may be acknowledged.
