In the reference cited, Government of Telangana have issued orders revising the rates of D.A. sanctioned to the employees of Government of Telangana from 12.052% of the basic pay to 15.196% of basic pay from 1st July 2015.

In view of the enhancement of DA from 12.052% to 15.196%, the General Manager (Finance), all District Managers and Zonal Managers, TSCSCL are hereby requested to revise DA from March 2016 pay bills onwards and draw the DA arrears from 1st July 2015 to 29th February 2016 @ 3.144% on the basic pay and make payment of arrears in cash in respect of the employees of Corporation.

Regarding the Deputationists working in the Corporation, the DA arrears shall be drawn in terms of Para 11 of the G.O. The revised DA shall be paid in cash with the salary of March, 2016. The arrears on account of payment of Dearness Allowance from 1st July 2015 to 29th February 2016 shall be credited to General Provident Fund account of the respective employees. However, in the case of employees who are due to retire on or before 31st May 2016, the arrears of Dearness Allowance shall be drawn and paid in cash.

The IOCPF of D.A. arrears (July 2015 to February 2016) shall be sent to Head Office along with April 2016 IOCPF. The D.A. arrears bill is

to be drawn to all those who are on pay rolls during the period covered in G.O. now communicated.
