Sub: APSCSCL-Pay Bills-Revision of D.A from 1st Jan 16-Payment of DA Arrears from 01/01/2016 to 28/02/2017 in cash-Reg.

Ref: GO Ms.No.16,Finance (HR Vi) Dept. Dated: 03/02/2017.

In the reference cited, Government of Andhra Pradesh have issued orders revising the rates of Dearness Allowance to the State Govt.employees in Andhra Pradesh Revised Pay Scales 2015 from 15.196% of basic pay to 18.34% of the basic pay from 1st Jan 2016. It is decided to implement orders issued in the reference cited revised DA w.e.f Jan 16 to the Corporation employees and release arrears in cash w.e.f Jan 16 to Feb 17 @ 3.144% on the basic pay.

In view of the enhancement of DA from 15.196% to 18.34%, the General Manager (Finance), all District Manager's and Zonal Manager's APSCSCL are hereby requested to revise DA from March 17 paybills onwards and draw the DA arrears from 1st Jan 2016 to Feb 17 @ 3.144% on the basic pay and make payment of arrears in cash in the month of April 17, in respect of the Corporation employees.

Regarding the deputationists working in the Corporation, the DA arrears shall be drawn in terms of Para no.11 of the G.O.The revised D.A shall be paid in cash with the salary of March 17 payable in the month of April 17.The arrears on account of payment of Dearness Allowance from 1st Jan 16 to 28th Feb 17 shall be credited to General Provident Fund account of the respective employees.

The IOCPF of DA Arrears (1st Jan 16 to 28th Feb 17) shall be sent to Head Office along with March 17 IOCPF. The DA Arrears bill is to be drawn to all those who are in the pay rolls during the period covered in G.O now communicated.


