The Commissioner of Civil Supplies & Ex Officio Secretary, Andhra Pradesh, Hyderabad ordered to constitute a Committee under the Chairmanship of VC & Managing Director, AP State Civil Supplies Corporation Limited, Hyderabad to fix uniform hamali charges vide the ref.2<sup>nd</sup> cited.

Accordingly, the Committee was constituted under the Chairmanship of VC & Managing Director, AP State Civil Supplies Corporation Limited Joint Collectors of Karimnagar, East Godavari, Warangal, the representatives of Commissioner of Marketing, CEO, SERP / Labour Department and Joint Director (Proc), O/o CCS & EOS, Govt. of AP, Hyderabad and discussed various aspects involved in fixation of uniform hamali charges. The Committee met on 22.03.2012 and discussed the matter in detail.

The Committee recommended a uniform rate of Rs.8/- per 40 Kg bag i.e. Rs.20/- per quintal of paddy for various operations involved in paddy purchases.

The Commissioner of Civil Supplies & Ex Officio Secretary, Andhra Pradesh, Hyderabad, vide the ref.4<sup>th</sup> cited, accepted the recommendations of the committee for fixation of Rs.20/- per quintal towards hamali charges ordered **that Rs.13.32 per quintal should be borne by the purchasing agency i.e. APSCSCL and the balance of Rs.6.68 per quintal shall be borne by the farmer who delivered the paddy to the Government Agency.**

The details of hamali charges to be borne by the farmer and the purchasing agency i.e. APSCSCL are as follows:

1. **Farmer** has to incur the expenses at Rs.6.68 per quintal of paddy i.e. Rs.2.67 per 40 Kg bag for unloading and heaping.
2. **The State Agency** i.e. APSCSCL will incur the expenditure of Rs.13.32 per quintal of paddy i.e. Rs.5.32 per 40 Kgs bag for filling, weighment, unloading from balance, stitching, marking, temporary stacking and loading into trucks.

In view of the above orders, the following guidelines are issued for immediate implementation:

1. The APSCSCL will pay Rs.13.32 per quintal of paddy i.e. Rs.5.32 per 40 Kgs bag towards the handling operations for procurement at its own PPCs as well as by IKPs / PACS/ DCMS/ others etc.
2. The farmers shall pay the handling charges at Rs.6.68 per quintal of paddy i.e. Rs.2.67 per 40 Kg bag for unloading and heaping.
3. No extra payment shall be made to the hamalies at procurement center.
4. Extra amount should not be collected from the farmers.
5. The handling charges to the agencies undertaking paddy purchases on behalf of APSCSCL shall be paid on weekly/ fortnightly / monthly basis on submission of detailed claim after due reconciliation supported by hamali receipts and a certificate stating that they have actually paid the hamali

charges at the prescribed rates and no amount was paid by / collected from the farmers. A separate cheque to be issued to societies by CSC for hamali payment.

6. These hamali charges shall come into effect **from 1.04.2012.**
7. Payment of hamali charges shall not be linked with the society / IKP commission payable to IKP / PACS/ DCMS/ others.
8. If any complaints are received that hamalies or IKP/ PACS/ DCMS have collected these hamali charges from the farmers the amount shall be recovered from the commission besides penalizing them
9. Wide publicity shall be given about the payment of hamali charges by the Govt. procurement agency and farmers should be made aware to avoid excess payment of hamali charges.
10. All MROs / RDOs / DM, CS / DSO/AD, Marketing / PD, DRDA / Others may be requested to ensure proper implementation of these orders.
