In the ref. 1st cited, the Government of Andhra Pradesh has decided entrust Decentralized Procurement of raw rice through levy in 7 districts and CMR in all districts to A.P.State Civil Supplies Corporation for the KMS 2012-13.

As per the orders issued by the Government vide ref. 3rd cited for the ensuing KMS 2012-13, A.P.State Civil Supplies Corporation will take up procurement of paddy and resultant CMR through out the state and in 7 districts i.e. Karimnagar, Nalgonda, Warangal, Guntur, Prakasam, Nellore and Chittoor procurement of raw rice under levy operation is also be taken up under DCP operation. In the remaining districts, the FCI will be responsible for procurement of raw rice under levy operation and boiled rice through levy operation or CMR in the entire State.

Arrangements for taking over the godowns of APSWC/CWC dehired by the FCI are made at Head Office level. In addition to this, the rice also be accepted in AMC and other godowns operated by APSCSCL.

Hence necessary arrangements for fixation of handling charges for procurement and release of rice at these godowns are to be made as detailed hereunder:

- 1. The handling charges finalized by APSWC/CWC godowns, hitherto paid by FCI, for rice procurement and release may be adopted for the raw rice procured by APSCSCL duly following the procedure in vogue in these godowns.
- 2. For AMC and other godowns to be maintained by APSCSCL, handling rates finalized and paid in the nearest APSWC/CWC godowns may be adopted to have uniformity of rates. If possible the work can be entrusted to the same handling contractor. If the contractors are not ready to undertake the work due to local problems, the work may be entrusted to the respective Hamali Unions duly fixing the rates, not more than prevailing rates of nearby SWC/CWC rates. There shall not be any additional burden to the Corporation on account of insurance, PF etc.
- 3. The JC & EOEDs are requested to review the matter and issue necessary orders before commencement of levy procurement.
