Sub:- APSCSCL – Marketing – Purchase of paddy under MSP operations – Farmer payment in three days - For strict compliance – Reg.

In continuation of the circular instructions issued in the reference 2<sup>nd</sup> cited, it is to further reiterate that the Corporation is keen on getting the payments by way of cheques delivered in 3 days time for this season (Khariff 2012-13) after paddy is accepted from farmer in paddy purchase centres (PPCs).

The matter is thoroughly discussed with the Joint Collectors in videoconference dated 16.10.2012 and the Collectors of 7 districts meeting on decentralized procurement of rice dated 17.10.2012 and decided to go ahead with delivery of farmer payments by way of cheques in 3 days time. However, the flexibility is provided to the District Collectors/Joint Collectors to take up **issue of cheques directly by the CS Corporation or to continue the existing practice** through procuring agencies like IKP, PACS etc.

In case of any district takes up direct payments by the CS Corporation, an expenditure is permitted to incur upto Rs 10,000/- per PPC towards engaging manpower and other contingent charges. Certain banks have also come forward offering their services for issue of cheques in bulk and they will be directed to approach the District Collectors/Joint Collectors in view of flexibility provided to them.

It is to inform that State Bank of India has given proposal for online funds transfer which will be taken up from the next season onwards so that farmer payments can be delivered on the same day on which paddy accepted in PPCs.
