Accordingly, Commission to Co-operative Societies / Self Help Groups payable from KMS 2013-14 onwards is as follows:

Subject: De-linking of Commission to Co-operative Societies/Self Help Groups from
Minimum Support Price (MSP).

Sir/Madam.

I am directed to say that at present Commission @ 2.5% of MSP for procurement of paddy in the Kharif Marketing Seasons and @ 2% of MSP on procurement of wheat in the Rabi Marketing Season are being allowed to the Cooperative Societies/Self Help Groups involved in procurement operations. However, the matter regarding de-linking of Commission to Co-operative Societies/Self Help Groups from MSP has been under consideration in this Department.

2. The Government of India announces support prices for various agricultural commodities including wheat, paddy and coarse grains. Government has to increase the MSP taking into consideration cost of cultivation and remunerative prices for farmers on their produce with a view to encouraging higher investment and production. With any increase in MSP, the charges towards 'Commission to Co-operative Societies/Self Help Groups' also get increased correspondingly without proportionate increase in cost of procurement.

3. It has, therefore, been decided to de-link Commission to Co-operative Societies from MSP and fix it at the level allowed in KMS 2012-13 and RMS 2013-14. Accordingly, Commission to Co-operative Societies payable from KMS 2013-14 and RMS 2014-15 onwards will be as under:-

2.	For procurement of Wheat from RMS 2014-15 onwards.	Rs.27.00/qtl



4. All States are, therefore requested to keep the above rate in view while sending their proposals for fixation of rate of procurement incidentals/economic cost for F&PD 2013-14 and RMS 2014-15 onwards. No request for allowing the Commission to S. eties over and above the rate indicated above will be considered in the Department and if any State allows the higher charges, then the additional expenditure involved will have to be borne by the concerned States/UTs from their own funds.

5. The "Principles" conveyed vide this Department's D.O. letter No.192(4)/2003-FC A/cs. dated.16th July, 2003 and modified vide letters of even number dated 3rd November, 2004, 14th March, 2005, 13th October 2006, 27th April 2007 and 5th December, 2007, 5th November, 2008, 4th September, 2009, 23rd March, 2010 and 18th October, 2011 and 16.10.2012 earlier shall stand amended to the extent, accordingly. All other terms and conditions of the "Principles" remain the same.


