SUB:- APSCSCL – Mktg – Rabi 2010 – 11 – Paddy procurement operations Certain instructions issued – Reg.

The paddy arrivals for Rabi 2010 – 11 are very heavy and the AP State Civil Supplies Corporation Limited has contracted for the purchase and supply of new gunnies through DGS & D and to augment the requirement of gunnies for the unprecedented arrivals of paddy orders were issued to the District Collectors for local purchase of new, once used and HDPE gunnies duly following procedure. Despite positioning of huge quantity of gunnies, reports of gunny shortages are still being reported in the media. There is a need of proper accounting of gunnies. Further huge quantities of paddy procured and bagged are lying in the paddy procurement centers due to non shifting to the rice mills. Due to onset of monsoon, the bagged paddy has to be immediately shifted to the tagged on rice mills or intermediary storage points to avoid damage to paddy stored in open areas at the IKP/PPC centers. Therefore the following instructions are issued to be followed scrupulously at the paddy procurement centers in the districts.

• The paddy procured at IKP/PPC Centers shall be transported to the tagged on rice mills immediately.

- On failure of paddy transport contractor for providing adequate lorries for paddy movement, the assistance of RTA may be utilized for requisitioning of more lorries for shifting of paddy.
- If huge quantities of paddy are procured during a day and cannot be immediately shifted to rice mills they have to be stored in vacant schools and colleges buildings.
- In case of transportation problems the paddy already bagged and not shifted to rice mills or intermediary storage points the same shall be covered with proper dunnage (tarpaulin) and properly stacked with CAP storage to prevent the paddy from getting damaged.
- Proper audit and accounting of gunnies has to be taken up by the District Administration in the district in respect of :

Receipts : AMC/MLS Point-wise

From DGS &D (AP Jute mills)

Inter-district receipts.

Private Jute Mills.

Local purchases

Rice Millers

Loan from FCI.

Loan from MARKFED

Utilisation: Issues from MLS Point to IKP /PPC centres. (Centre-wise)

AMC to IKP / PPC centres. (Centre-wise)

Closing balances:

Storage point-wise AMC-wise IKP-wise

Separate teams are being constituted and shall be sent to the paddy procurement districts from the Head Office for verification of gunny and paddy reconciliation.
