SUB:- APSCSCL – Marketing – Procurement of paddy under MSP operations – Heavy arrivals of paddy – Shifting of paddy to Rice Mills and intermediary godowns - Instruction issued – Reg.

In the reference 1st cited, Government of Andhra Pradesh have issued orders for transportation of paddy procured by the AP State Civil Supplies Corporation Limited through PPC / IKP Centres to the designated rice mills to arrange for custom milling of the paddy within 15 days by the concerned rice millers. Due to unprecedented arrivals of paddy in the market yards and IKP centres there has been delay in shifting of paddy from the procurement centres to the designated rice mills.

It has been reported by the e Marketing authorities and the CEO, SERP informing that there is delay in lifting of paddy from the procurement centres and this is causing congestion at the centres and also lack of space for new arrivals It has also been reported that there is delay in unloading of paddy from the trucks by the rice millers due to various reasons. The Collectors (CS) were requested vide reference 3rd cited to ensure prompt lifting of paddy from the procurement centres in coordination with the Road Transport

A uthorities and also to form teams with the enforcement officials from Revenue and Civil Supplies to avoid delay in unloading of trucks at rice mills.

In view of the unprecedented arrivals of paddy and the delay in shifting of paddy due to transport and other problems, it is imperative to store the paddy in intermediary godowns to ensure prompt shifting of paddy from the procurement centres and create space for the new arrivals.

CAP storage has also been resorted to in the Market yards in some districts. In view of the above, the following guidelines have been issued:

- Suitable godowns for intermediary storage of paddy are to be identified and taken possession of the same for a limited period of one to two months.
- Paddy has to be transported by the authorized transport contractors.
- There shall not be any backward movement of paddy. The godowns shall be located between the PPC and the designated rice mills.
- There should not be any movement of paddy from one intermediary godown to another intermediary godown.
- Uniform handling charges are to be fixed for unloading and loading of paddy from trucks at intermediary godowns by the District Empowered Committee.
- The details of intermediary godowns shall be informed to the Head Office and also to the concerned Insurance Companies for insurance coverage..
- Insurance coverage is to be obtained for the paddy stocks in CAP storage.
- Huge quantities of paddy have to be handed over to the designated rice mills for custom milling. Hence proper documentation with millers has to be ensured as envisaged in the Government orders.
- The paddy deliveries to the designated rice mills shall be in accordance with the milling capacity. If paddy deliveries are more than the milling capacity the CMR deliveries to FCI will be delayed. Hence this aspect has to be reviewed on day-to-day basis.
- The paddy stock delivered to the Rice Mills for custom milling shall be under the joint custody of the miller and the local officer designated by the Joint Collector in the cadre of not less than the Dy. Tahsildar (CS). Necessary orders shall be issued in this regard to avoid any misappropriation of stocks by the rice miller. If the miller contravenes any of the conditions of the agreement entered with Civil Supplies Corporation, the defaulting miller shall be blacklisted and proceeded against under the provisions of AP Rice Procurement (Levy) order 1984.
