Quantitative and Financial Reconciliation of Paddy Accounts  
and Gunny Accounts – Payment of IKP Commissions - Reg.

A quantity of **19,44,885 MTs** of Paddy purchased during Rabi 2010-11 under MSP operations in various districts. Out of this **17,27,898 MTs.** of Paddy was procured through IKP Groups. Instructions were issued for reconciliation of paddy procured by IKP Groups, quantity shifted to Rice Mills / intermediary godowns and Gunnies supplied to IKP Groups, utilized for paddy procurement and balance available with IKP Groups. The procurement of paddy for Rabi 2010-11 was completed by the end of June.2011. Though 2 months period is completed the reconciliation of Paddy & Gunny Account has not been completed.

It is also very essential to pay the commission to the IKP Groups 2.5% of the MSP for the quantity procured by them. Some of the Joint Collectors were also requesting for release of advance commission to the IKP Groups.

The quantitative and financial reconciliation of Paddy Accounts and Gunny Accounts is essential for settlement of IKP commissions.

Therefore all Joint Collector & EOEDs, APSCSCL are requested to review this item of work with the District Managers of APSCSCL and PD, DRDA and direct them to complete the reconciliation of the Paddy and Gunny Account within a week positively and to send detailed reconciliation statement for Paddy and Gunnies handled by the IKP Groups.

The District Managers of APSCSCL are also directed **to arrange payment of commission @ 2.5 % to the IKP Groups for the quantities purchased by them immediately after completion of reconciliation of accounts.**

**This may be treated as most important and urgent and the action taken in this regard may be informed by 10.09.2011.**
