REVISED CIRCULAR MEMO

Sub: APSCSCL - Administration- Revision of seniority lists employees of APSCSCL undertaken in pursuance of the interim direction of the Hon'ble High Court in W.P.No.42898/2017 - Final Seniority lists of all cadres of employees in APSCSCL as on 01.06.2014 were published on 04.03.2025 - Aggrieved by the said lists certain employees filed writ petitions vide W.P.No. 8090 and 8717 of 2025- Hon'ble High Court of AP passed certain interim orders - Departmental Promotion Committee was constituted to review the DPC panels for the years 2018, 2020 and to prepare fresh panels for the years 2021-2022 to 2024-25 -DPC Committee verified and approved - Communicating the Revised Roster panels for the years 2018, 2020 and fresh panels prepared for the years 2021-22, 2022-23, 2023-24 and 2024-25 of all cadres in the APSCSCL - Objection called for - Reg. In pursuance of the interim directions of the Hon'ble High Court in $W.P.\ No.\ 42898/2017$, the revision of seniority lists of employees of

APSCSCL has been undertaken. After following the due procedure, the Final Seniority Lists of all cadres of employees in APSCSCL as on 01.06.2014 were published on 04.03.2025 vide reference 1st cited.

Challenging the said lists, **W.P. Nos. 8090 and 8717 of 2025** were filed before the Hon'ble High Court of Andhra Pradesh by seven employees, namely: Sri B. Balakrishna, Sri B. Raju, Kum. D. Sharmila, Sri D. Arjuna Rao, Smt. G. Lakshmi, Smt. G. Sirisha, and Smt. J. Jayanthi.

The Hon'ble High Court, while hearing the above writ petitions, passed the following order:

- 2. In view of the written instructions and submissions made by the learned Additional Advocate General, as it is stated that no immediate promotions or reversions are to be undertaken and that a final seniority list would be prepared after calling for objections from all stakeholders once again to cover the period up to date in all cadres, let counter affidavit be filed within four weeks and reply affidavit, if any, may be filed within two weeks thereafter.
- 3. List these two matters after eight (8) weeks.
- 4. In view of the statement made by the learned Additional Advocate General, let the exercise of processing and preparing the fresh final seniority list go on, subject to further orders."

Consequently, a **Departmental Promotion Committee (DPC)** has been constituted to review the subsequent DPC panels for the years **2018 and 2020** and **to prepare fresh panels for the years from 2021-2022 to 2024-2025**, to enable promotions in APSCSCL in all the cadres. The Committee comprises the following members:

- 1. Vice-Chairman & Managing Director, APSCSCL
- 2. Joint Secretary, Service Section, GAD
- 3. Additional Director (Admn.), Civil Supplies Department
- 4. Asst.Secretary, CA F&CS Department.
- 5. Manager (Audit), APSCSCL, Head Office

The panels for the years 2018 and 2020 were reviewed, and fresh panels for the years 2021-22, 2022-23, 2023-24 & 2024-25 were prepared and the same were duly verified and approved by the DPC members.

Now, as per Rule 24 of AP State and Subordinate Services Rules 1996, the revision of panels for the years 2018 and 2020 are being communicated for making a representation against the proposed revision before any order of revision is passed. Further, fresh panels for the years from 2021-2022 to 2024-2025 have also been communicating

to all the employees of APSCSCL for their reference.

Hence, all the concerned employees in the said panels are hereby directed to submit their Objections if any, with due supporting evidence or documents to Head Office, Vijayawada **within (10) days** from the date of receipt of this communication, failing which it will be presumed that they have no objections to submit and the Provisional Seniority List will be issued as per the prevailing rules in force.

The Managers in Head Office, all the District Civil Supplies Managers and Zonal Managers of APSCSCL are requested to communicate the revised panels (2018 & 2020) and fresh panels (2021-22, 2022-23, 2023-24 and 2024-25) to all the employees concerned working under their control without fail and send the served copies to the Head Office for record purpose.
