2.1.Insured/Proposer:

The Andhra Pradesh State Civil Supplies Corporation Ltd. is a State Agency appointed by the State Government and vested with the responsibility to undertake transportation of foodgrains under PDS. In 2021, the APSCSCL has launched the Mobile Dispensing Units (MDUs) with the primary objective of door delivery of Essential Commodities at the doorstep of the BPL Cardholders under Public Distribution System.

The corporation, had purchased 9260 NOs (Units) of Mobile Dispensing Units (MDUs) TATA Motors / MARUTI make ~ 4 (Four) wheeled auto tippers for door-to-door delivery of foodgrains under PDS in the urban and rural areas across the state of Andhra Pradesh.

The (proposed) vehicles were purchased by the corporation in the year 2021. The vehicles were registered in the month of January 2021 as Goods Carriage LMV. The proposed vehicle are about 4 (four) years old.

 - 5.1.2. Issuance of policies shall be made available in the jurisdiction of branches located in the Andhra Pradesh State, for easy approach by the MDU operators and further correspondence.
 - 5.1.3. A dedicated team from the insurance company shall be available to the MDU operators at the district level for clarification on insurance coverage, assistance in claiming the insurance, and other insurance related queries.
 - 5.1.4. In case of non-adjustment amount towards non-renewal of MDUs insurance for any reason, such amount shall be returned to the APSCSCL with remarks.
